

If the question were one of trifling importance and temporary character, - if the stage, to which the proceedings have arrived, and the course proposed to be pursued in regard to them did not involve doctrines extending to the fundamental principles of our political federative system of government, he certainly would not have intruded himself at this moment upon the notice of the public. But Maine protests against being condemned unheard. She solicits, she demands as an act of justice of her sister States, of the United States, of the high-minded Representatives of the States and of the People of the United States, the Senators and Members of Congress, a patient and thorough investigation before pronouncing a decision. She asks of them not to search for plausible pretexts in order to get rid of an uncomfortable subject and relieve themselves from a supposed present inconvenience; but to deal out to her that measure of even-handed justice, which shall tend to give strength and durability to the union by strengthening the confidence of the individual States. He has subjoined in an Appendix the letter of Mr. Preble to Mr. McLane of 25th January, 1831, considering it as presenting a succinct abstract of the whole merits of the original controversy.
